



Thank you for your interest in Old Valley Farm. We are a Local Wholesale Grower of perennials, ground covers, grasses and shrubs. Unlike Retail Nurseries that give professional discounts or Re-Wholesalers, Old Valley Farm is a Grower that sells directly to Industry Professionals at true wholesale prices. Thus, there are certain criteria regarding who is eligible to receive and order from our weekly availability lists, minimum orders and lead time for us to pull and prep orders before pick-up or delivery.

To open a Wholesale Account, we require two things: 1) an Idaho Nurseryman's License and 2) the applicant must be actively engaged in a landscape related business.

TERMS OF SALE

PRICES: The prices listed on the Availability List are intended for the trade only.

PAYMENT: All sales are cash until credit has been established. With approved credit, payment is due 30 days from invoice date. A 1.5% per month service charge will be added to past due account. A 3% discount is given on Cash Sales.

HOLD ORDER & CUSTOM ORDER: Plant materials that we are asked to hold will be invoiced when it is deemed ready for sale and removed from inventory. Hold Orders not paid for according to the terms of your account will be returned to inventory and a 15% restocking fee assessed. A 15% restocking fee will also be assessed on Nursery Pick-Up left over 48 hours. A 30% deposit will be required on all Custom Growing Orders.

CLAIMS & WARRANTIES: Our guarantee is simple. If our material does not meet your expectations, we will replace it or issue a credit. All claims on plant material must be made within 5 days of delivery. All orders are subject to stock on hand at time of delivery. We cannot be liable for more than the invoiced price nor can we be liable for product deterioration on Hold Orders or shortages on Contract Growing Orders due to crop failures.
